He is the Founder- Publisher cum Chief Editor of **SMART Journal of Business Management Studies**, a Referred, Indexed, Professional and International Journal (www.smartjournalbms.org) since 2005. He was the Former Dean, Faculty of Management, Former Chair for School of Business Studies, Former Director i/c, UGC Academic Staff College, **Former Member of Syndicate and Senate**, Former Coordinator of Centre for Entrepreneurship and Skill Development, Former Coordinator-NITI Aayog (University Level) and Former Coordinator, Centre for Financial Market.

Education: Born in a small village in Ariyalur District of Tamil Nadu, he obtained his B.Com from A.V.C. College, Mayiladuthurai and M.Com., from Annamalai University. He pursued Doctorate in Commerce from the same University in 1992. Additionally, he acquired **Master of Arts in Distance Education (MADE)** from IGNOU, New Delhi in 1998 and Masters in Business Administration(M.B.A) from Periyar University in 2012. Also, he obtained **D.Litt. in Management** from Bharathiar University in 2017.
